- a) "Company Profile" containing details of bidder capacity , capability and technical expertise, production manufacturing ability, TQM, corporate customers, work orders, management /skilled manpower profile / strength & logistic structure, design and CAD CAM facility details, list of machinery such as High Speed Cutter, High Speed Paper Cutter, High Speed Wood Sanding Machine, High Speed Router Machine, KT Machine, Post Forming Machine, Hydraulic Hot Press, Gauger Machine, Wood Planner, ARA Machine (Small), ARA Machine (Big), Edge Bending Machine, Paint booth and any other relevant information that support the scope of work of bid.
- b) Price of the bidding document is Rs.1,500/- (One Thousand Five Hundred Only) each as per rule 23(5) of Public Procurement Rules, 2004 submitted through Pay Order/Bank draft drawn in favor of "**National Bank of Pakistan**".
- c) Companies who have manufactured two or more furniture supplies of each worth of one (01) Million Pak Rupees or above during last three (3) years are eligible to bid.

- e) NTN/GST Certificates.
- f) A certificate from bidder that they have never been declared blacklisted by any Government / Semi-Government or autonomous body and Litigation history on judicial stamp paper of worth Rs. 100/-.
