

TERMS AND CONDITIONS FOR TENDER.

- 1- The payment shall be made as per measurement of work done at site duly verified by the respective VP/Head (HVAC) Engineer of Engineering Division.
- 2- Rate should be quoted on item basis as details in the B.O.Q.
- 3- The time limit will be 4-8 weeks from actual date of start as per work order issued by the Procurement Executive / Officer. In case the contractors fails to complete the work within the stipulated period a penalty of Rs.500/- per day shall be levied to the maximum of 10% of the total cost of work. Agreement will be treated as cancelled automatically and work may be completed through some other agency at the risk and cost of the contractor.
- 4- Bid Security shall be submitted in shape of payment order issued by the NBP or any scheduled Bank or Bank Guarantee.
- 5- Bid Security shall be released after 03 months from the date of satisfactory completion of works on account of maintenance period.
- 6- After execution of Contract Agreement, Substantial Responsive Bidder will be termed as "Contractor".
- 7- If at any stage the VP/Head (HVAC) or Resident Engineer finds that the progress of work is not satisfactory and that the contractors not be able to complete the works within the time limit. He has full rights to get the work executed through some other agency at contractor's risk and cost.
- 8- After the expiry of time the work still remain incomplete. This may be completed, through some other agency, without giving any notice to the contractors at his risk and cost.
- 9- All work shall have to be carried out strictly according to the specifications any work not up to the specifications will have to be dismantled and re-laid or its rates will be reduced if otherwise accepted by the VP/Head (HVAC) or Resident Engineer (HVAC). In this connection the decision of the said Engineers will be final and binding upon the contractors.
- 10-Any extra item carried out by the contractors will be paid as per the rates of similar items include in tender of the contractors. However if no similar item exists in tender the rates as fixed by the VP/Head (HVAC) or R.E (HVAC) will be final and binding upon the contractors without appeal.
- 11-Quantities of item may decrease or increase or some items may be omitted at the discretion of the VP/Head (HVAC) or R.E (HVAC) at site.
- 12-If any items of work are carried out which is not covered in the tender the rates fixed by the VP/Head (HVAC) or R.E (HVAC) at site for such item will be final and binding on the Contractors.
- 13-The Contractors in his own interest should get for such item approved by the VP/ Head (HVAC) / Divisional Head (Engr.) before executing the work.
- 14- In case of any dispute arising during the execution of this contracts the decision of the VP/Head (HVAC)/ Divisional Head (Engr.) will be final and binding upon the Contractors and without appeal.
- 15-The rates quoted by the Contractors shall be binding on the Contractors for a period of 06 months from the date of Tender and no fluctuation of any sort in material, labor.

- **16-** During the above period the Contractor will not claim and increase in prices of any sort or escalation due to any cause or condition.
- 17-Poor quality work should not be accepted any circumstances.
- 18-The payment of final bill will be made when the certificate of completion of work is submitted from respective / department / Wing / Group / Branch and contractor must submit No claim Certificate before payment of Bills.
- 19-The tender will be received and opened publicly as per criteria laid down in advertisement.
