- Firms should have average turnover of at least 10 Million over the past three years and generally sound position. (Please provide audited financial statement of last 03 years).
- Companies who have furnished two or more such supplies of each worth of four (04) Million Pak Rupees or above during last five (5) years are eligible to bid.
- An application on **Company’s letter head** is required for issuance of Bidding Documents
- Provincial / FBR Tax Registration Certificate of Income Tax & Sales Tax. Name of bidder must appear on Active Tax Payers List of FBR.
- A certificate from bidder that they have never been declared blacklisted by any Government / Semi-Government or autonomous body and Litigation history.
- Bid Validity period 120 days

This is a “Single Stage, single Envelope Bidding Procedure” as per **Rule 36 (a) of PPRA 2004**, and same will be adopted. The sealed bid accompanied with separate bid security (as mentioned above) in the form of Payment Order/CDR in favor of National Bank of Pakistan should be in sealed envelope alongwith bid.
