

Procurement of Penetration Testing Software

5. **Details of related works in hand with cost, name of clients and expected year of completion.**
6. **Copy of National Tax Number.**
7. **Copy of Registrations with Govt. Sales Tax Department**
8. **Banker's certificate indicating credit worthiness of the firm with the Bank.**
9. **Details of after sales facilities/support.**
10. **Affidavit that the firm has never been blacklisted by any Government/Semi Government organization or Autonomous Bodies.**
11. **List of any arbitration/dispute with any client present or past and nature thereof.**
12. **Copy of Dealership Certificate from Original Equipment Manufacturer (OEM).**
